



MEDIA ACCREDITATION RULES

Welcome to Rally Liepāja!

We kindly invite you to get acquainted with the Media accreditation rules of Round 2 of the 2015 *FIA European Rally Championship* and Round 1 of the 2015 *FIA ERC Junior Championship* and Rounds 2 & 3 of the 2015 *Latvian Rally Championship*.

BASIC PRINCIPLES OF ACCREDITATION

The media accreditation is envisaged for:

- journalists
- media photographers
- TV/video cameramen
- Competitor representatives

Accreditation is not envisaged for advertising, marketing or public relations agencies, as well as for representatives of sponsors.

Please, complete the Media Accreditation Application Form (hereafter, Form) carefully. Incorrect and/or incomplete Forms will not be considered.

Upon submission of the Form, the media representative shall resolve duly and correctly inform the auditorium of the represented media about the event before and after the event, as well as to correctly use the official title of the rally – "Rally Liepāja".

Upon request of the organiser of the rally (hereafter, Organiser), each accredited representative is obliged to provide to the Organiser the evidence of journalist activity.

Only persons having reached the age of 18 at the time of submission of the Form will be accredited.

Accredited media representatives are allowed to use ground-controlled flying objects. It is mandatory to receive a permit from the Organiser.

SPECIAL PROVISIONS FOR PHOTOGRAPHERS, RADIO JOURNALISTS AND TV/VIDEO CREW

Photographers, radio journalists and TV/video cameramen willing to receive accreditation, media tabard and be entitled to be present in dangerous areas of the track shall have **life insurance policy (including for motorsports competitions) with the value of at least EUR 1500**.

Media tabards for accredited media will be available for a guarantee fee of EUR 50.

Handing over of the received media tabard to another person is strictly prohibited!

The accredited media representative with the media tabard issued by the Organiser is entitled to be present in the dangerous areas of the track or especially envisaged media zones; though, no further than 1 (one) meter away of the safety demarcation (fence, stripe, other).



The accredited media representative with the media tabard and media armband issued by the Organiser is entitled to be present in dangerous areas of the track or especially envisaged media zones further than 1 (one) meter away of the safety demarcation (fence, stripe, other).

The Organiser reserves a sole right to distribute media armbands to selected media representatives. There is no special application form for the media armband.

SUBMISSION OF MEDIA ACCREDITATION APPLICATIONS FORMS

Filled-in Form shall be received via e-mail or online submission no later than January 23, 2015.

The Organiser will not assess Forms that are incomplete, faulty or received after the deadline.

Confirmation or denial of the accreditation application shall be sent to an e-mail provided in the Form. The e-mail is scheduled to be distributed on February 2, 2015.

Journalists (printed media) and photographers

Respective media shall complete an online Form provided by the Organiser. The link to the online form will be found on the official website of the rally <u>www.lvrally.com</u>. The accreditation procedure is carried out by the Organiser.

Journalists (websites), radio correspondents and TV/video crew

Respective media shall complete a Form supplied by *Eurosport Events*, available on the official website of the rally <u>www.lvrally.com</u>. Form should be sent to <u>fia_erc_accreditations@eurosport.com</u> and <u>janis@raevents.lv</u>. The accreditation procedure is carried out by *Eurosport Events*.

ISSUE OF ACCREDITATION

Granting and/or rejecting accreditation is fully in hands of the Organiser of *Rally Liepāja*, *Eurosport Events*, and the number of accredited media representatives is limited by size of the media centre and by warrantee of their safety at the track of the competition.

The media cards and the media tabards will be available in the Media Centre. The media cards and the media tabards can be received only in person.
